VEHICLE RENTAL CONTRACT AGREEMENT

Policy

Oxford Service Company, Inc. dba/Oxford Automotive, will provide to its customers, depending upon availability, a rental vehicle for their use while their vehicle is being serviced at our facility. This service is available only to qualified driver's who meet the criteria listed in the "Terms and Conditions" below. The charge for this rental vehicle is a flat fee of \$24.00 for the duration of the repair. Customer is responsible for refilling the fuel in the rental vehicle. Customer will be charged \$24.00/day for each additional day that they keep the rental vehicle after they have been notified that their vehicle repair has been completed.

Terms and Conditions

The following criteria must be met by the driver renting the vehicle owned by Oxford Service Co., Inc.

Driver must:

1. be 21 years of age.
2. show proof of adequate automobile liability insurance.
3. have no major traffic violations in previous 5 year period. Major traffic violations include the following:
 - Driving under the influence of alcohol or drugs
 - Driving with a suspended driver's license
 - Driving while intoxicated
 - Felony involving a motor vehicle
 - Fleeing or eluding an officer
 - Hit and run (leaving the scene)
 - Homicide or assault with a vehicle
 - Operating a vehicle without permission
 - Recklessness/Reckless operation
 - Racing/Drag racing
 - Other major violations
4. No more than one minor violation in previous 3 year period. Minor violations include the following:
 - Failure to request a report
 - Failure to yield
 - Following too closely
 - Improper passing
 - Improper turn
 - License/credentials
 - Speeding
 - Traffic device/sign
 - Wrong way/1-way street
 - Other minor violations
5. show proof of valid driver's license.
6. not smoke in rented vehicle
7. not allow rented vehicle to be driven by any other person.
8. agree to return rented vehicle promptly after their vehicle is repaired.
9. not allow pets in rented vehicle
10. return rented vehicle in the same condition in which it was taken.

Warranty

I agree that I have read and do meet the conditions for renting the vehicle as outlined above. I agree to abide by the terms outlined above. I agree to pay \$24.00 to rent this vehicle. As the driver of this vehicle, I will be responsible for any and all damage incurred to this vehicle or any other property while this vehicle is in my possession. I agree that I am responsible for refilling the fuel used in the rental vehicle. I understand that I will be charged \$24.00/day for each additional day I keep the rental vehicle after I am notified that my vehicle has been repaired. I understand and agree that my credit card will be charged for fuel refilling @\$3.00/gallon and \$24.00/day additional use.
